AGREEMENT IN RELATION TO THE PARTICIPATION IN THE 2nd SEN MASTER ACADEMY & CSK TAEKWON-DO SPECIAL EDUCATIONAL NEEDS AND INVITATIONAL TAEKWON-DO MARTIAL ARTS CHAMPIONSHIP 2019 ("The Agreement")

By registering for the 2nd SEN MASTER ACADEMY & CSK TAEKWON-DO SPECIAL EDUCATIONAL NEEDS AND INVITATIONAL TAEKWON-DO MARTIAL ARTS CHAMPIONSHIP 2019, the participant agrees to The Agreement as follows:-

1. LIABILITY, REPRESENTATIONS AND WAIVER

- a. As a participant, I recognize and assume the risk that, as a participant in the Free Sparring Events, other participants and competitors will be using all techniques possible to win such competitions. As a result of such techniques, I assume the risk that I will be subject to injury, which may result in injury or death. Risk of injury includes (but is not limited to):
 - i. injuries arising from use of equipment, machines, and facilities within Oasis Village; and
 - ii. injuries arising from participation in supervised or unsupervised activities or programs during the Tournament.
- d. I certify that I am healthy, and have not been advised by any doctor, coach, or trainer not to compete for medical or other reason.
- e. I hereby grant permission for trained medical technician to provide first aid to me in the event of an injury, and such, will hold harmless such technician for all services performed in a reasonable manner.
- f. I hereby accept any and all financial obligations incurred as a result of such immediate medical treatment, and subsequent related costs.
- g. I agree to indemnify SEN MASTER ACADEMY, CLASSIC TAEKWON-DO ACADEMY AND CSK TAEKWON-DO for all costs related to treatment administered during Tournament.
