COMPETITION FORMAT – ROUND ROBIN

Competition Format:

- Competitors will be 'Grouped' into groups of 4 competitors; in the fairest way possible (dependent on entries – some groups may have 5, or 3 participants).
- Rules for the event are consistent with the Australian Karate Federation's rules for Junior Categories, at State and National events.
- Wherever possible; competitors will all receive the same number of opportunities to compete, and will all receive medals.

Rules & Regulations

1. Should there be insufficient numbers in any of the divisions, the organizers reserve the right to combine divisions, as they deem fair.
2. If the Competitor is under the age of 18 years their parent or legal guardian must sign the waiver.
3. All Competitors and Coaches must abide by the rules of the Event.
4. All Competitors must abide by the Judge's decision.
5. All Competitors must have personal injury insurance and a current member of the Australian Karate Federation to compete in this event.
6. All Competitors must wear the appropriate protective equipment in their events. Mitts, mouth guards, groin guards (for males) and chest guards for women
7. All entries must be fully completed with correct information, and then returned with the appropriate fees to their dojo instructor.
