



United Mirae Kuk Sool (UMKS) Tournament Terms & Refund Policy



These terms and conditions shall govern your participation in the United Mirae Kuk Sool (herein referred to as UMKS and Organizer) Tournament organized by UMKS. By participating in the Tournament, you agree to be bound by these terms and conditions, including the refund policy referenced below.

1. Tournament Registration:

Participants must register for the Tournament through the official registration process specified by the Organizer. Each participant must provide accurate and complete information during registration. Participants will be required to pay a registration fee, as determined by the Organizer and number of categories entered.

2. Eligibility:

The Tournament is open to individuals of any age, provided they meet any additional eligibility requirements specified by the Organizer. Participants under the age of 18 must obtain parental or guardian consent before participating.

3. Tournament Format:

The Organizer reserves the right to determine the format, rules, and schedule of the Tournament. Participants must abide by all rules and regulations set forth by the Organizer. The Organizer may disqualify any participant found to be in violation of the rules.

4. Tournament Cancellation or Rescheduling:

The Organizer reserves the right to cancel, postpone, or reschedule the Tournament due to unforeseen circumstances, including but not limited to, insufficient registrations, venue unavailability, natural disasters, or force majeure events. In the event of a cancellation or rescheduling, the Organizer will provide participants with a refund of the registration fee less any processing fees, if applicable, and as requested.

5. Refunds:

Refunds will only be provided in accordance with the Tournament cancellation or rescheduling policy, as stated in section 4. Refund requests must be submitted to the Organizer within the specified timeframe, as communicated by the Organizer in section 6. The Organizer reserves the right to deny refund requests for participants found to be in violation of the rules or policies.

6. Refund policies for tournament withdrawals or inability to participate due to extenuating circumstances may vary; however, here are a few common scenarios for handling refunds:

a. Tournament withdrawal before it starts: If a participant decides to withdraw from the tournament two weeks prior to the tournament date, a full refund, less any processing fees, will be issued. If a participant decides to withdraw from the tournament one week prior to the tournament date, a 75% refund, less any processing fees, will be issued. If a participant decided to withdraw the day of the tournament prior to 8am, a 50% refund, less any processing fees, will be issued. Any requests made after 8am the day of the tournament will not be eligible for a refund in any amount. Time zone used is determined by the tournament location. All requests must be submitted in writing to office@umks.net

b. Extenuating Circumstances: In case a participant is unable to participate due to unforeseen extenuating circumstances (such as serious injury, illness, or a family emergency), tournament organizers may consider refund requests on a case-by-case basis. Participants involved in such situations should inform the organizers immediately, providing relevant documentation or proof of the circumstances, such as a letter from an employer or a letter from a physician. The decision to provide a refund, the amount of the refund, or any

alternative options (like transferring the registration fee to a future tournament) will depend on the discretion of the organizers. Refunds will be less any processing fees. All requests must be submitted in writing to office@umks.net.

c. All refunds will be issued to the original payment method used for registration. If unavailable, an alternative method may be used at the Organizer's discretion.

d. The Organizer reserves the right to modify the refund policy and will provide 30 days notice of any changes. Changes will only apply to future registrations.

7. Participant Conduct:

Participants must conduct themselves in a respectful and sportsmanlike manner throughout the Tournament. Any form of cheating, harassment, or inappropriate behavior will not be tolerated and may result in disqualification and removal from the Tournament without refund. No refunds will be provided for participant discipline/disqualifications due to misconduct.

8. Publicity and Media:

By participating in the Tournament, participants grant the Organizer the right to capture, record, and use their name, image, likeness, and voice for promotional and media purposes without any compensation.

9. Medical Treatment:

Medical treatment given at the UMKS Tournament will be of the first aid treatment type only.

10. Limitation of Liability:

I, as the undersigned, hereby waive all claims against any or all persons, schools and groups associated with the UMKS Tournament. I agree to **INDEMNIFY, AND HOLD HARMLESS** United Mirae Kuk Sool, LLC, Sungjin Su, its affiliates, members and volunteers, from any claims resulting from any loss or damage suffered by myself or any family member as a result of our child/ward's participation. I have read this **RELEASE** and understand all its terms. I execute it voluntarily and with full knowledge of its significance.

I hereby assume all risk of physical and mental injuries, disabilities, and losses which may result from or in connection with my participation in the UMKS Tournament. I am fully aware of the participant's medical condition and hereby certify that they are mentally and physically fit to compete.

Participants are responsible for their own safety and well-being throughout the Tournament.
