



2026 FNB CHAMPIONSHIP PREPARATION RUN

INDIVIDUAL COMPETITOR PARTICIPATION WAIVER, INDEMNITY AND RELEASE OF LIABILITY

I hereby apply to participate in the “2026 FNB CHAMPIONSHIP PREPARATION RUN” ("the Event") and acknowledge, agree and declare as follows:

1. Assumption of Risk

I understand that participation in karate, kobudō and related activities involves inherent risks, including injury, illness, disability, property damage and, in exceptional circumstances, death. I voluntarily assume all risks associated with my participation in the Event.

2. Medical Fitness

I declare that I am medically fit and physically capable of participating in the Event. I have disclosed, or will disclose, any medical condition, injury or illness that may affect my participation or the safety of others.

3. Release and Indemnity

To the fullest extent permitted by law, I release and discharge the Shotokan Karate Academy International (SKAI), the World Union of Karate-Do Federations (WUKF), the Event Organising Committee, host clubs, affiliated organisations, officials, referees, judges, coaches, instructors, volunteers, sponsors, venue owners and their representatives from any claims, liabilities, losses, damages, costs or expenses arising directly or indirectly from my participation in the Event, except where caused by gross negligence or wilful misconduct.

I further agree to indemnify and hold harmless the above-mentioned persons and organisations against any claim, liability, loss, damage or expense arising from my participation, breach of Event rules, negligent conduct or unlawful actions.

4. Medical Treatment

I authorise the organisers and appointed medical personnel to administer or arrange emergency medical treatment if required. I acknowledge that any medical, hospital, transport or related expenses remain my responsibility, or that of my parent or legal guardian where applicable.

5. Media Consent

I grant SKAI, WUKF and the Event organisers the unrestricted right to photograph, film, livestream and record my participation and to use such images or recordings for promotional, educational, archival, social media, television, website or other lawful purposes, without compensation.

6. Compliance with Rules

I agree to comply with all WUKF competition rules, Event regulations, venue requirements and instructions issued by officials and organisers. I understand that failure to comply may result in disqualification or removal from the Event.

7. Minors

Where the participant is under 18 years of age, the parent or legal guardian signing below confirms that:

- he or she has read and understood this document;
- consents to the minor's participation;
- accepts the terms of this waiver on behalf of the minor; and
- confirms that the minor is medically fit to participate.

8. Declaration

I confirm that I have carefully read and fully understand this Participation Waiver, Indemnity and Release of Liability. I understand that by signing this document I may be waiving certain legal rights and I do so freely and voluntarily.
