



2026 FNB CHAMPIONSHIP PREPARATION RUN

TEAM ENTRY WAIVER, INDEMNITY AND RELEASE OF LIABILITY

I, the undersigned, in my capacity as the duly authorised representative of the Federation, Organisation, Association, Club or Team named below ("the Team"), hereby register the Team and its members for participation in the 2026 FNB CHAMPIONSHIP PREPARATION RUN ("the Event") and acknowledge, agree and declare as follows:

1. Authority

I warrant that I am duly authorised to enter competitors on behalf of the Team and to bind the Team to the terms of this Waiver, Indemnity and Release of Liability.

2. Assumption of Risk

The Team acknowledges that participation in karate, kobudō and related activities involves inherent risks, including injury, illness, disability, property damage and, in exceptional circumstances, death. The Team voluntarily accepts and assumes such risks on behalf of its officials, coaches, managers and competitors participating in the Event.

3. Individual Competitor Indemnities

The Team confirms that every competitor entered for the Event has completed, or will complete prior to participation, an individual Participation Waiver, Indemnity and Release of Liability. Where a competitor is under the age of 18 years, the Team confirms that the required parent or legal guardian consent has been obtained and retained by the Team. The Team shall make such documents available to the organisers upon request.

4. Medical Fitness

The Team confirms that, to the best of its knowledge, all competitors entered are medically fit and physically capable of participating in the Event and that any relevant medical conditions affecting participation have been disclosed to the appropriate officials.

5. Release and Indemnity

To the fullest extent permitted by law, the Team releases and discharges the Shotokan Karate Academy International (SKAI) the World Union of Karate-Do Federations (WUKF), the Event Organising Committee, host clubs, affiliated organisations, officials, referees, judges, coaches,

volunteers, sponsors, venue owners and their representatives from any claims, liabilities, losses, damages, costs or expenses arising directly or indirectly from the participation of the Team or any of its members in the Event, except where caused by gross negligence or wilful misconduct.

The Team further agrees to indemnify and hold harmless the above-mentioned persons and organisations against any claim, liability, loss, damage, cost or expense arising from:

- (a) the participation of Team members in the Event;
- (b) any breach of Event rules or regulations by Team members;
- (c) negligent, reckless or unlawful conduct by Team members; or
- (d) any claim arising from the Team's failure to obtain the required competitor or parental consent forms.

6. Medical Treatment

The Team authorises the organisers and appointed medical personnel to administer or arrange emergency medical treatment where required and acknowledges that all related costs shall remain the responsibility of the competitor, parent, guardian or Team concerned.

7. Media Consent

The Team acknowledges and agrees that competitors, coaches, officials and supporters may be photographed, filmed, livestreamed or recorded during the Event and grants permission for such material to be used by SKAI, WUKF and the Event organisers for promotional, educational, archival, social media, television, website and related purposes without compensation.

8. Compliance with Rules

The Team agrees to comply with all WUKF competition rules, Event regulations, venue requirements and instructions issued by the organisers and officials. Failure to do so may result in disqualification, disciplinary action or removal from the Event.

9. Declaration

I confirm that I have read and understood this Team Entry Waiver, Indemnity and Release of Liability and that I sign it freely and voluntarily on behalf of the Team.
